2017 MEMBER SURVEY FINDINGS

Firm Size

- Almost half are sole proprietors
- Another 20% are in firms with more than 100 employees

Firm Specialties

- Sustainability/Environment, Natural Resources, Energy (44%)
- Housing and Community Development (43%)
- Small Town and Rural Planning (39%)
- Economic Development (35%)
- Transportation (33%)
- Urban Design/Historic Preservation (22%)
- Hazard Mitigation (6%)
- Federal Planning (4%)

47 Responses

- 20% in 201-2019 school year

 - Post to social media outlets on PPD's behalf (21%)
 - Help organize PPD awards program (9%)
